



**MOOVE LUBRICANTS LIMITED TERMS AND CONDITIONS FOR PRIZE DRAW AT
AUTOMECHANIKA EXPO**

These terms and conditions ("**Terms**") apply to a Prize Draw ("**Promotion**") at the Automechanika Trade Fair, held in Birmingham, United Kingdom ("**Event**"), between 6 and 8 June 2023, which is offered by Moove Lubricants Limited ("**Company**"), owner of the Comma trademark and manufacturer of the Comma-branded products. By entering the Promotion, participants agree to be bound by these Terms.

1. ELIGIBILITY

1.1. The Promotion is open to residents of the United Kingdom who are aged 18 years or over at the date on which they enter the Promotion, except employees of the Company, their families, agents, and employees of any third-party companies who are directly associated with the Company and the Promotion.

2. HOW TO ENTER

2.1. This Promotion will start at 09:30 on 6 June 2023 and the closing date for this Promotion will be 8 June 2023 at 16:00 ("**Event Period**").

2.2. Participants must collect their Comma cards at the Company’s stand before taking a Qualifying Activity (as defined below).

- 2.3. To enter the Promotion, participants must take at least one of the following steps (each a “**Qualifying Activity**”; together “**Qualifying Activities**”) during the Event Period:
 - 2.3.1. Check-in with one of the Company’s representatives at the Company’s stand at the Event;
 - 2.3.2. Play the Company’s speed game in the stand as indicated during the Event. The speed game entails pressing a light button in the fastest time the participant can;
 - 2.3.3. Play the Company’s power game in the stand as indicated during the Event. The power game entails hitting a hammer the strongest a participant can;
 - 2.3.4. Attend one session of a Comma Talk titled “How new vehicle technology will impact engine oil in 2023 and beyond” at the Event as hosted by the Company; and/or
 - 2.3.5. Book a workshop workout (standard booking form enclosed as Annex B) taking place by the end of 2023.
- 2.4. The Company will distribute stamps (“**Stamps**”) to participants who successfully perform Qualifying Activities at the Event and only during the Event Period. These Stamps will be affixed to the participant’s Comma card by the Company. The Company will only distribute one Stamp per each Qualifying Activity set out in each of the sub-clauses 2.3.1 to 2.3.5 Accordingly and for the avoidance of doubt, the Company will distribute a maximum of 5 (five) Stamps to each participant who successfully completes all the Qualifying Activities set-out under sub-clauses 2.3.1 to 2.3.5.
- 2.5. No purchase is necessary to enter or win the Promotion.
- 2.6. Participants must return their Comma cards containing their affixed Stamps to the Company’s stand at the Event during the Event Period. Participants who fail to return their Comma cards by this time will be disqualified and will not be entered into this Promotion.

3. STAMPS

- 3.1. Stamps cannot be transferred, bought, sold, or in any way traded. Stamps have no monetary value.

- 3.3. Stamps are valid during the Event Period only and cannot be used in conjunction with any other offer or promotion.
- 3.4. The Company reserves the right to limit, amend, or withdraw Stamps if a participant is found to be in breach of these Terms.
- 3.5. Each Stamp will give a participant one chance to have their name drawn in the awarding of prizes pursuant to clause 5 of these Terms.

4. PRIZES

- 4.1. The prizes for the Promotion are described in Annex A to these Terms.
- 4.2. Prizes are limited in number and their reasonable estimates are provided, together with a statement of their nature and description, in Annex A.
- 4.3. In the event that a prize is no longer available, the Company will make reasonable efforts to provide an alternative prize of equal or greater value. No cash alternatives to prizes will be offered.
- 4.4. All costs and expenses not included within the prizes are the responsibility of the winner(s).
- 4.5. Unless agreed otherwise in writing by the Company, prizes will only be awarded to the winners.
- 4.6. Any images are an illustrative example and do not show the exact prize(s).

5. SELECTION OF THE WINNERS

- 5.1. Each Stamp entitles the participant one entry into the Promotion for the chance to win one of the prizes identified in Annex A. Each participant may only enter the Promotion using a singular Comma card, and the Comma card may hold a maximum of 5 (five) Stamps.
- 5.2. The winners will be chosen at random in accordance with the laws of chance using a randomizer generator computer software, which shall produce a verifiable random result, from all eligible entries received during the Event Period in accordance with these Terms.

- 5.3. The Company will draw names within 30 (thirty) days of the end of the Event Period (“**Prize Draw Day**”), until all prizes are awarded to winners, and the Company will draw eligible winning names at least 85 times.
- 5.4. The Company reserves the right at any time, in its absolute discretion, to:
 - 5.4.1. verify the eligibility of any participant (including their age and place of residence);
 - 5.4.2. disqualify any participant found to be abusing or tampering with the operation of the Promotion or entering using fraudulent means, or who the Company believes to have acted in breach of these Terms; and
 - 5.4.3. disqualify participants who do not give correct contact details or those who make an entry on someone else's behalf.

6. NOTIFICATION OF THE RESULTS

- 6.1. The Company will notify the winners by e-mail or telephone number within 15 (fifteen) days of the Prize Draw Day.
- 6.2. The winner must respond to the notification sent by the Company within 7 (seven) days to claim their prize. If the winner does not respond within this time frame, the prize will be forfeited and the Company reserves the right to select an alternative winner from the remaining eligible entries in accordance with the process described above.
- 6.3. The winner is advised to check and is responsible for any tax implications which may arise as a result of claiming the prize.

7. PUBLICITY

- 7.1. By entering this Promotion, participants agree to the use of their personal information for the purposes outlined in Clause 8 below. 8.3. The Company relies on the following legal bases in processing this data:

8.3.1. its legitimate interests in administering the Promotion; and

8.3.2. where applicable, participants' consent.

8.4. Where participants have provided express consent, we will also use this personal information for marketing purposes, including but not limited to sending promotional emails, newsletters, and other marketing communications. Participants may withdraw their consent to receiving such communications at any time by following the unsubscribe instructions provided in the communication.

8.5. Participants have the right to access, correct, delete their personal data. For more information in relation to these rights, and how to exercise them, please consult the Company's privacy policy

- 9.3. The Company's failure to enforce any right or provision of these Terms will not constitute a waiver of such right or provision.
- 9.4. Each of the clauses of these Terms operates separately. If any court or relevant authority decides that any of them are unlawful or unenforceable, the remaining clauses will remain in full force and effect.

10. LIMITATION OF LIABILITY

- 10.1. The Promotion is not in any way sponsored, endorsed or administered by, or associated by Automechanika Trade Fair organisers.
- 10.2. Subject to clause 10.3, if the Company fails to comply with these Terms, it will be responsible for loss or damage participants suffer that is a foreseeable result of the Company's breach of these Terms. The Company is not responsible for any loss or damage that is not foreseeable.
- 10.3. Insofar as is permitted by law, the Company will not be liable for: (i) any failure to comply with these Terms as a consequence of events beyond its reasonable control including without limitation, any failure of communication networks as a consequence of any circumstances beyond the reasonable control of the Company; and/or (ii) any

11. LAW AND JURISDICTION

- 11.1. The Promotion and these Terms, and any dispute or claim arising out of or in connection with them, will be governed by and construed in accordance with English law and participants can bring legal proceedings in respect of the Promotion and these Terms in the English courts. Participants living in Scotland will also benefit from any mandatory provisions of Scottish law and can bring legal proceedings in respect of the Promotion and these Terms in either the Scottish or the English courts. Participants living in Northern Ireland will also benefit from any mandatory provisions of the laws of Northern Ireland and can bring legal proceedings in respect of the Promotion and these Terms in either the Northern Irish or the English courts.
